## PHOTOS

- Two identical passport photos that are 2 inches by 2 inches in size.
- Write your full name and birth date on the back of the passport photos.

## FORMS

- Print Form G-1145
- Print Form I-821D
- Print Form I-765
- Print Form I-765WS

## DOCUMENTS

- Valid Work Permit or Approval Notice
- Social Security Card - Copy of the front and back
- Copy of your Initial DACA Application (optional)

## FILING FEES

- Check or Money Order for \$495 made out to: U.S. Department of Homeland Security
- Money Orders can be purchased at a bank or post office. Do not use the initials "USDHS" or "DHS."

## CRIMINAL RECORD

- Request a copy of your Criminal Record from your local Police Department

If you have been arrested since you have had DACA, request a copy of your Criminal Record from your local Police Department and consult with an immigration attorney before submitting your application.

If you don't want to go to your Police Department, we can request a copy of your FBI criminal record if you purchase our **Kit de Huellas Digitales en Español para Solicitud de Antecedentes Penales del FBI** off our website
